Overview:

This course will examine the social aspects of phonetic variation, focusing particularly on the relationship between method and theory. Students will be introduced to the field through a survey of contemporary research from variationist sociolinguistics, linguistic anthropology, experimental phonetics and laboratory phonology. Basic methods for studying the production of different types of phonetic variables including vowels, consonants, tones, voice quality/phonation, and prosody, etc. will be introduced to give students the foundational tools for conducting sociophonetic work. How both sounds and speakers are perceived, and the implications of both inter- and intraspeaker sociophonetic variation for theories of sociolinguistics and phonetics/phonology will also be discussed.

Students will be assessed by 3 essays (2000 words each) summarizing and critically evaluating research articles read in class, 1 in-class presentation of an article of choice and by a research project proposal of the students' design at the end of the semester.

Prerequisite: LIN 3010

Objectives: By the end of this course, students should:

- Be able to examine phonetic variation/change using techniques and theories from sociolinguistics, linguistic anthropology, experimental phonetics and laboratory phonology.
- Be able to apply acoustic analysis techniques to investigate phonetic variation/change.
- Be able to design a research project on phonetic variation/change suitable for a senior thesis (for under graduate students) or academic conference (for graduate students).
