Overview:

The phonological systems of the world -- the principles that govern how sounds function in language -- exhibit a fascinating range of highly organized patterns. This course examines some of the classic problems of phonology and introduces the theoretical tools that have been proposed for solving them. We will study phonemic and morphophonemic analysis, distinctive-feature theory, the formulation of rules and constraints, the problems of abstractness and rule ordering, and the formalization of phonological representation. The course focuses on problem solving in phonological analysis, presenting insights from current phonological theories and applying them to a range of natural language data.

Prerequisites: Graduate Status; ideally also the equivalents to Lin3010 (Introduction to Linguistics) & Lin 3201 (Sounds of Human Language)

Objectives:

On completion of this course, students should be able to:

- recognize common phonological processes, and appreciate similarities among the phonological systems of a range of languages
- use the formalism of generative phonology, including distinctive features, rewrite rules, rule ordering, and constraint ranking to capture phonological processes
- analyze language data to extract phonological generalizations, and construct arguments from such data to support or to weaken proposals for particular analyses
- identify the kinds of data that can crucially distinguish among theoretical approaches, and discuss the implications of specific data to the construction and development of phonological theory

Assessments

- **On-line Reading Quizzes**: Practice quizzes are on Canvas for each chapter of the readings we cover; these quizzes close around the time that we discuss the reading in class. Quizzes grouping chapters together (Hayes1-2, Hayes 3-4, etc.) can be taken during the 4 days before the dates on the schedule (9/1, 9/17, 9/29, 10/11, 10/25, 11/8), and contain a subset of questions from the practice quizzes. Each of the 6 quizzes is worth 1% (=10 points).
- Homework: Four homework assignments (10% each) throughout the course: due: 9/10, 10/6, 10/29, 11/12. To be distributed roughly one week before they are due, on Canvas (e-Learning).
- Tests:Two tests (timed) on Oct 13th (Covers Weeks 1-7, 12%) and Nov 19th (Weeks 1-13, 14%).
The final is a take-home, due Dec 16th (entire course, 16%)
- **Team Presentations**: In teams of 2-3, you will present your solution to a problem given in advance. During week 14 of classes, about 20-25 minutes per team (8%).
- **Comprehensive Exam Practice:** During weeks 13 & 14, four ½ hour comprehensive exam questions will be made available on Canvas, and you are required to answer at least one. They are graded out of 10 (bonus) points, and I will count the one on which you score the highest.
- **Participation:** I expect you to attend class regularly, participate in class discussions, group activities, and problem solving. You may be chosen to present your solution to a problem that we work on in small groups (4%).
