Class Meeting Times

This is a face-to-face class, which means that we will meet regularly on Tuesdays and Thursdays as listed above under "class meeting times".

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

Course Description

In this class, we will familiarize ourselves with key concepts, theories, and empirical research on child and adult second language acquisition (SLA).

Course Objectives

By the end of this course, you will have acquired the ability to intelligently discuss aspects of the theory and practice of language learning based on knowledge of the scholarly research in the field. You will also have learned how to analyze learner data both for research purposes and to inform ESL teaching practice.

Course Credit Requirements and Grading

Exams: 33% (11% each). There are 3 exams. Each exam counts towards 11% towards your final grade. The exams will be due on the dates listed on the course schedule and are submitted on Canvas.

Recorded Recent Research Presentation: 20%. Groups of one or more students will prepare a video recording of a published research article (the articles are all available on CANVAS). Presentations should not exceed 15 minutes in length. The presentation should end with at least two discussion questions. For the recording, you can use Zoom, VoiceThread, or any other recording software that allows for free sharing of the recording via a link or file. Recorded research article presentations are due on the due dates as shown on the course schedule. Submit the link or file under the corresponding assignment on Canvas.

Recent Research Discussion Boards: 24% (3% each). You will participate in 8 Canvas Discussion Boards in which you watch a recorded presentation of a research article by a group of your peers, respond to questions as listed on the Discussion Board, and leave comments for peers as instructed on the Discussion Board. The Discussion Board responses are due on the due dates shown on the course schedule and are submitted on Canvas.

Recorded Theory Presentation: 23%. Groups of one or more students will prepare a video recording of a summary of one chapter in the [VKW] textbook (see Technology and Materials Requirements below for a listing of the two required textbooks for this class). Presentations should not exceed 25 minutes in length. For the

recording, you can use Zoom, VoiceThread, or any other recording software that allows for free sharing of the recording via a link. Recorded research article presentations are due on the due dates as shown on the course schedule. Submit the link or file under the corresponding assignment on Canvas.

Attendance and Participation

Attendance is mandatory for all class meetings. You are allowed to miss up to three 50-minute class periods (lectures and TA sections combined) without any excuse. Each further unexcused absence will lower your grade by one level (e.g. from an A to A-).
